New State Guidelines

Beginning in Distance Learning

The governor announced on Friday that any district whose schools are in a county that is on the state "watch/monitoring" list will not be able to open for in-person learning until they are off that list for 14 days. We will continue to communicate to families if and when this changes. **For our school district, this means that we will begin classes in full distance learning on August 18, 2020.**

Masks

The governor provided new statewide mask requirements for schools (once in-person learning resumes). These include:

Student Face Covering Requirements

Age	Face Covering Requirement
2 years - 2nd grade	Strongly encouraged. Face shield can be worn instead of mask
Third grade and above	Yes, unless exempt according to CDPH guidelines

1. All staff must wear face coverings unless exempt
2. Schools are being required to exclude students from campus if they are not exempt and refuse to wear a mask provided by the school. If you do not feel comfortable sending your child to school in a mask, please contact the district office at (707) 545-0102 to discuss distance learning options for your child.
3. Children can remove their masks for meals and outdoor recreation.

Our Next Steps

Because we were already preparing for distance learning, we are well-prepared to respond to the state's new requirements. Roseland School District teachers, administrators, and other school staff are developing a strong distance learning program to begin on August 18, 2020. This includes:

- Loaning school-issued Chromebooks to all TK-8 students so that all students are using a common device.
 - Access to software students use at school, such as Lexia and IXL, will be easily accessible from the school Chromebooks.
- Having Chromebooks available for loan for all high school students who need one.
- Providing daily live virtual instruction with teachers.
 - Including opportunities for students to virtually collaborate with their peers.
- Providing books and learning materials to balance technology based learning with paper/pencil and hands-on learning.
- Providing structured school schedules with clear expectations for students. These will be provided to families before the first day of school.
- Providing ongoing support, including assistance with utilizing technology, to students and families.
- Providing additional services to help support students and families, including counseling services, school meals, additional tutoring, etc.

*** Please note that participation and completion of school work will be required, and students will be graded on their work.**

Additional Information

School lunches during Distance Learning:

Meals will be distributed two times per week on Tuesdays and Thursdays, time to be determined (more information to come). You can fill out an application for free/reduced priced meals now at our district office located at 1691 Burbank Ave, Santa Rosa, CA 95407.

School Sports:

At this point all school sports have been put on hold, we will reevaluate in December.

FAQs

Q: When will our schools reopen for in-person instruction?

A: Under the new guidelines, schools cannot open for in-person learning as long as their county is on the state's monitoring/watch list. The county must be off the watch list for 14 consecutive days before a school can consider offering in-person learning. We will be closely monitoring the watchlist and will update you if and when anything changes.

Q: How is my school/district ensuring high-quality distance learning?

A: The state has clearly outlined how all schools should ensure high-quality distance education. This includes:

- Access to devices & connectivity for all kids
- Daily live interaction with teachers and other students
- Engaging assignments equivalent to in-person classes
- Adapted lessons for English language learners and special education students

Q: Will my child need to wear a mask to school under the new policy, once in-person learning resumes?

A: All children who are in third grade and higher are required to wear a mask unless they are medically exempt. Children in grades TK-2 are strongly encouraged to wear a mask. They can also wear a face shield.

Q: Will the school provide a mask for my child once in-person learning resumes?

Each school will have a supply of child-sized masks for any student who needs one or forgot to bring a mask. However, we encourage you to get some masks for your child as part of their back to school supplies. Getting masks in a design that your child likes can make it easier for them to wear the mask.

Q: Once in-person learning resumes, will students have to stay six feet apart?

A: The state guidelines say that children should remain six feet apart where possible, but recognize that this may be hard to strictly enforce. Adults are asked to stay six feet apart from other adults and children.

Q: Will school staff and students need to be tested for COVID-19 once school campuses reopen?

A: According to the state, school districts and schools shall test staff periodically, *as testing capacity permits and as practicable*. Examples of recommended frequency include testing all staff over two months, where 25% of staff are tested every two weeks, or 50% every month to rotate testing of all staff over time. The guidance does not require testing for children. We are working with the Sonoma County Office of Education and the Sonoma County Health Department to determine how testing will be conducted.

Q: Once schools reopen, will they need to close again if there is a confirmed case among a student or staff member?

A. The new state guidance clearly outlines what should happen if there is a confirmed case of COVID-19 on a campus, which is outlined in the chart below. In each case, the school district will work closely with the Sonoma County Department of Health Service’s contact tracing team.

Confirmed COVID-19 Case:

Classroom	School	District
Close class if one or more children/employees have a confirmed case	Close school if multiple classes OR 5% of total student/staff population have confirmed cases	Close if 25% of all schools are closed due to COVID-19
