Plan Descriptions

All actions in the Expanded Learning Opportunities Grant Plan are aligned with Goal 2 of the Local Control Accountability Plan (LCAP) which states "Increase student achievement and social/emotional wellbeing for all students, with an emphasis on closing the achievement gap and attaining equity for English language learners, students from socioeconomically disadvantaged backgrounds, students with exceptional needs and students in need of learning acceleration due to COVID-19 pandemic." The goals and actions of the LCAP undergo an extensive stakeholder engagement process including engagement with students, parents, teachers, SELPA, governing board.

In addition, surveys were sent out to students, parents, teachers and staff asking for their priorities on the actions/services that are the most effective in supporting student learning and overall success.

District and site leadership provided additional input to support the development of the plan.

The plan was sent via email to all staff for review and feedback.

The plan was sent to parents via our parent messaging system for review and feedback.

The plan was posted on the district website in English and Spanish.

The plan was shared with staff at a staff meeting on 5/10/21 and a DELAC/Parent Advisory Committee meeting on 5/12/21 and feedback was be sought.

A description of how students will be identified and the needs of students will be assessed.

At a district, school site, grade level and classroom level, assessment data will be analyzed regularly to assess the needs of the student. This includes the use of STAR reading/math assessment results, and IXL diagnostic at secondary level. Teachers will also use formative assessments and progress on IEP goals as appropriate (for students with disabilities) to determine ongoing learning needs.

Social-emotional needs will be assessed throughout the year with Core SEL. Students identified as needing social emotional support are referred to the Coordinated Services Team (CST). Counselors provide additional whole class push in support and trainings as well as small group and 1:1 student support. Additionally, teachers incorporate social-emotional learning standards into instruction through classroom community building activities.

Parents will be informed of the opportunities for supplemental instruction and support in both English and Spanish in the following ways:

- School and districtwide communications (in English and Spanish) via ParentSquare notifying parents of all the resources, plans and available opportunities for students.
- Back to School Night and Middle School parent conferences
- Individualized recommendations made through phone calls or electronic messages through ParentSquare.
- Targeted interventions and supports will be recommended through the coordinated services process.
- Discussion on supplemental instruction and support specific to individual students may also occur as appropriate during IEP meetings.

A description of the LEA's plan to provide supplemental instruction and support.

All of the actions listed below are aligned with a tiered framework that bases universal, targeted, and intensive supports on pupils' needs for academic, social-emotional, and other integrated student supports. Our program of engaging learning experiences in a positive school culture is demonstrated in the actions of our LCAP under goal 1 "Provide a well-rounded education with access to a robust and engaging curriculum as well as enrichment, technology and extracurricular activities." and Goal 3 "Provide welcoming, safe, well-maintained facilities conducive to 21st century learning and other basic/district services that support daily operations of sites."

Students in need of additional supports will be identified through a referral process to the Coordinated Services Team (CST). This group made up of principals, teachers, counselors, and community partners once per week during the school day to review referrals sent by staff, teachers, and administrators. This team evaluates the referred students' needs and provides them with psychosocial or academic

interventions geared specifically for them, involves family members when possible, and links students with school and community resources. Additionally, psychosocial counseling groups are provided for all students to help with depression, stress management, anxiety, grief, and other struggles characteristic of adolescence. Family members are involved throughout the process and are given support in accessing school and community resources.

Our plan includes:

- Trauma informed professional development
- 3 full-time Social Emotional counselors
- Summer school
- 3 full time Math intervention teachers
- Additional Secondary Support Staff

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The ELO grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds. All strategies above will have additional funds from the federal Elementary and Secondary School Emergency Relief Funds. All funding is being used to support all students in learning acceleration, social emotional and physical well being, providing greater student engagement in academics and extracurricular activities, growing school staffing at levels required for interventions and student supports, maintaining safe and clean facilities as directed by the California Department of Public Health and ventilation opportunities, technology and connectivity. The different funds available will be assigned according to the regulations and rules for each one for the 2020-21 school year though the 2022-23 school year.

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
